

International Standard File Specification

Introduction

The International Standard File contains data on each stock that is present in the Ford International Universe of stocks as they existed on the last business day indicated by the file name.

The history files contain a data point for each data where data was collected for the universe of stocks. The files are named IntlHistyyyymmdd.txt (where yyyymmdd represents the date of the database) and delivered in a zip file IntlHistyyyymmdd.zip.

The bi-monthly files contain one data point for the universe of stocks, from the beginning or middle of the month. These files are named IntlCurryyyyymmdd.txt (where yyyymmdd represents the date of the database) and delivered in a zip file IntlCurryyyyymmdd.zip.

All fields are delimited by a tab. Values in the database that are not available are represented by a null field. The first record contains column headings.
